- Identify cases of opioid withdrawal and advise on buprenorphine dosing to treat withdrawal
- Provide guidance on treatment of precipitated withdrawal
- Troubleshoot care transition planning to bridge patients to outpatient treatment
- Improve medication safety to help decrease risks of harm, including overdose
- Discuss useful care and communication strategies regarding substance use and pain

While PCSS provides trainings on a broad range of substance use disorder treatments, its primary focus is on treatment of ppioid use disorders (OUD). Opioids include a class of drugs often prescribed for pain—morphine, fentanyl, oxycodone, and hydrocodone—as well as illicit drugs, such as heroin. The Federal Drug Administration (FDA) has approved three medications for the treatment of OUD: methadone, buprenorphine, and naltrexone.

The introductory module below is a case-based discussion of the general approach to evaluation and treatment of patients presenting with problematic opioid use. Benefits and limitations of available medications and differences between them are described. An approach to choosing first and second line treatments is also presented.
