## **Breakout Room 1:**

### Review and discuss potential areas for improvement your site could address based on your QI data.

- Prescribe mostly methadone; working on same day admits over zoom to increase number of bup patients
- Demographics: missing some populations so trying to target those (several sites working on this)
  - Need to target underserved populations
- Not effective at co-occurrence with meth use (need something in place to deal with meth co-occurrence)
  - We all can improve co-occurring meth/stim/ alcohol use
  - One site using the TRUST protocol
  - One site has a goal to pilot CM for stimulant use disorder

## Pick one site represented in the breakout room and work together to brainstorm possible change projects based on the site's QI data.

#### Focus on demographics:

- Spanish language materials (outreach materials, clinic materials)
- Diverse providers
- More interpreters
- Find what the barriers are to access care (what are the next steps)
- Advertising in multiple languages (english/spanish)

## What specific ideas for rapid cycle change projects will you bring back to your administrative team?

- Co-Occurring MH: add psych/np in outreach
- Advertising /outreach more specific outreach
  - Advertising isn't working at one site
  - Try movie theaters, parent magazines. Articles.
  - Utilize peer support people in the same demographics for outreach. Could help with confidentiality concerns.

## Breakout Room 2: Mendocino Community Health Clinic

### Review and discuss potential areas for improvement your site could address based on your QI data.

- Change in admission for new MAT patients (they are an FQHC- 1 company with 3 sites in the county)
- Large Latin/Hispanic population of the community, but they are not being served. Only 1 provider who is Bilingual.
- Need for treatment for patients who struggle with Methamphetamines but no current treatment options at this time (Perhaps understanding that they do not need to be in a program per se to document their treatment type).

## Pick one site represented in the breakout room and work together to brainstorm possible change projects based on the site's QI data.

- Consideration for increasing outreach: Meetings, local communitynew physician who is expanding the program, or introducing yourself
- Consider making it more personable (Business cell phone- folks contact more directly especially via Text.)
- There is not much availability as we would like to see -- wait time is longer than it should be. (Certain days providers see clients)
- Foster relationship with local hospital

## What specific ideas for rapid cycle change projects will you bring back to your administrative team?

- Simple outreach. Dedicated phone line with a text option. Look at the outreach and how long the retention is to see if that impacts data
- Consideration of working with homeless shelter- provide them with contact information once established, possible handouts
- Starting outreach with the jails (jail gives a bridge of 1 week)

## **Breakout Room 3:**

### Review and discuss potential areas for improvement your site could address based on your QI data.

- Aegis Eureka admitting a good number of pts per month; more sustainable funding sources coming with new Medi-Cal contracts etc. We have experienced a huge demand, very little outreach needed.
- Western Sierra Medical Trying to get more providers waivered; many find overwhelming. Could increase access for patients. Only 2 peer counselors, no LCSWs. Psychosocial supports are needed.
