What is CIOSC?

CIOSC serves as a source for Tribal & Urban Indian entities to share information regarding Local Opioid Coalition attendance and/or development, share community best practices, collaborate and learn from one another, host training sessions, and build strategic partnerships and relationships.

CIOSC topics range from OUD, alternative methods to pain management, harm reduction, traditional ways of healing, naloxone administration, general public health, MAT, Opioid/SUD data trends, etc.
